# **DUTIES OF STANDING COMMITTEES**

## **Bylaws Committee**

The chairperson works with her committee to oversee compliance with State and Club Bylaws. The committee reviews Club Bylaws to ensure compliance with the template. State Bylaws are reviewed for compliance with NFRW Bylaws. The Bylaws Committee works in consultation with the Parliamentarian. Advise and insure that the Executive Committee and Board of Directors follows the TFRW Bylaws when a breach has occurred. Provides guidance in the understanding and execution of the duties and policies of the RWRC.

# Campaign / Political Activities Committee

The chairperson maintains and verifies campaign hours submitted by members. She sends out reminders to members, coordinates all campaign hours, and compiles a report for president.

### **Budget and Finance Committee**

The chairperson is the fundraising chair and devises opportunities for raising money. She should have items for sale at meetings and events to sell for the RWRC.

#### **Legislation and Research Committee**

The chairperson informs members of current legislative actions.

### **Membership & Outreach Committee**

The chairperson works with the Second Vice President to helps promote membership throughout the state.

**Public Relations / Publicity / Communications Committee** -The chairperson sends out notices and press releases to newspapers, radio and TV regarding RWRC information also includes newsletter, website, email)



# **Caring for America Committee**

The National Federation of Republican Women (NFRW) established the Caring for America program in 1999 to encourage state federations and clubs to actively participate in at least one community service program. Caring for America is based on the belief that problems can be solved most effectively through the generosity and combined energies of individual citizens.

Caring for America programs may be completed by the state or club individually or in collaboration with other community agencies. Republican women always step forward when they see an area that needs assistance, whether it is hands-on or through donations of needed food or other commodities. The NFRW Caring for America Committee compiles a comprehensive list of activities that is provided to all Federated Republican women's clubs.

The Caring for America Committee consists of region leaders from various member states who each work with the state presidents in their assigned region to promote the Caring for America program. These region leaders meet before the national biennial convention to review submissions from state presidents to determine the NFRW Caring for America Award winners in each size category. The NFRW recognizes each winner with a certificate at the biennial convention.


